## 1. Acceptance of Terms

If you do not agree with any part of these terms, you are advised not to access the Website.

## 2. Terms & Conditions

The user hereby agrees, acknowledges and confirms that the user:

- (i) is a holder of a valid driving licence issued under the Motor Vehicles Act, 1988;
- (ii) is not prohibited from owning a vehicle in the jurisdiction of purchase;
- (iii) can understand and agrees with the contents herein; and
- (iv) has read, understood and agrees to be bound by these Terms (by clicking on the check box).

The user acknowledges that the images and colours displayed on the Platform are representations of the actual **Hestur** vehicle. Hestur Energy Pvt Ltd has made every effort to ensure accurate representation. However, the actual vehicle, including images and colour, may vary depending on the model purchased, and no guarantee is made regarding exact visual match.

If the user is booking or purchasing on behalf of another person, the necessary details of such person are required to be provided, and relevant documentation must be submitted at the dealership.

The user agrees and declares that the following information shared on the Platform for booking a Hestur vehicle is true and accurate:

The user understands and agrees that these details will be used by **Hestur Energy Pvt Ltd** and the respective dealership to contact and communicate with the user.

All formalities relating to the purchase of a Hestur vehicle, including but not limited to the registration process, shall be completed at the designated dealership. The sale and delivery of the vehicle are contingent upon fulfillment of all applicable statutory obligations and submission of the necessary original documents at the dealership. Failure to comply may result in the cancellation of the booking/purchase, and any amount paid will be refunded without interest.

**APPLICABLE TO USERS WHO HAVE MADE A PRE-BOOKING:**

The user agrees and understands that the pre-booking amount shall be adjusted against the selected plan. Upon confirming the booking of the Hestur vehicle, the user shall be required to pay the balance amount as per the plan selected.

### **3. Acceptance Booking**

Once completion of payment of the booking amount in accordance with the selected plan:

The user must complete the verification of documents at least 7 days prior to delivery at the dealership.

Please note, if the user fails to make payment in a timely manner in accordance with the My hestur Plan selected by the user and confirmed by the lending partner, **Hestur Energy Pvt Ltd** reserves the right to disconnect the user's access to the Hestur vehicle and stall it from being used until payment is completed to the satisfaction of the lending partner. Further, failure to make payment may result in repossession (applicable to owners with the My Hestur Plan).

The booking amount paid by the user in accordance with the selected plan by the user is made through a payment gateway and accordingly the user is subject to the terms and conditions as provided by the payment gateway intermediary/merchant service provider. **Hestur Energy Pvt Ltd** shall not be responsible for any non-payment or wrong payment/accuracy or completeness of the information, services, or process of the third-party site.

### **4. Booking Terms**

Hestur energy Pvt Ltd will not be responsible for any delay, loss or non-receipt of online booking information or any other form of submission not contemplated herein Hestur Energy Pvt Ltd reserves the right to change the Dealership for the purpose of sale and delivery of the Hestur vehicle as selected by the user and the same shall be communicated to the user through email/message. Irrespective of the payment method selected, the waiting period and the tentative delivery slot are communicated by Hestur energy prior to the user making payment of the booking amount.
